## Taxpayer Assistance Programs

Dear Fellow Taxpayers:

As your Wayne County Treasurer, it is my honor and privilege to serve you. Please be advised that to be compliant with Michigan law, starting next year, the final date to enter into a payment plan wil be **March 14, 2022**, and the last day to pay your forfeited taxes to the Wayne County Treasurer's Office will be

March 31, 2022. Our office will begin offering the payment plans for 2019 and prior years' delinquent taxes in July 2021 instead of October as we have in the past.

## **Payment Plans**

(Many of these are available online at treasurer.waynecounty.com)

#### Interest Reduction Stipulated Payment Agreement (IRSPA)

This payment plan reduces the interest rate from 18% to 6% for eligible taxpayers. To sign up, you must own and live in your home, and have a Principal Residence Exemption (PRE) and ID that proves residency.

#### Distressed Owner Occupant Extension (DOOE)

This program is not available to everyone. If you own and live in the property, and are suffering financial hardship you may qualify for this program. Proof of ownership, occupancy, and hardship are required.

#### Stipulated Payment Agreement (SPA)

Available to everybody, this plan allows a taxpayer to pay taxes pursuant to a payment schedule. The plan will avoid foreclosure provided that payments are submitted per the agreed upon schedule.

#### Pay As You Stay Payment Agreement (PAYSPA)

Only for those who have first applied for their local municipality's Poverty Tax Exemption (PTE) and received an approval. Once notified by your local Assessor's office and deemed eligible, our office will mail you a notification letter with your Reduced Amount Due. You will have the option of paying a lump sum (additional 10% off) or enrolling into a PAYSPA.



## How to get into a payment plan online


Getting into a payment plan is quick and easy. It can be done online. The Wayne County Treasurer's Office offers several payment plans to assist distressed taxpayers with paying delinquent taxes.

These plans are explained on the Treasurer's Office website. By following the steps outlined below you can find which plan may work best for you — and then use it. Here's how:

- **Step 1:** Go to the Wayne County Treasurer's Office website: Treasurer.waynecounty.com
- **Step 2:** From the home page, select "Payment Plans" from the menu bar. A drop-down menu will appear. Select "Payment Plans" from the drop-down menu.




**Step 3:** Scroll down to the blue box that reads, "Click here and see if you are eligible and to apply."

**Step 4:** This will open up a new menu welcoming you to our property tax system. Click "Continue." Enter the address of the property or select the parcel ID tab to enter the parcel ID. Then click "search."

**Step 5:** The property tax bill will show on the screen, as well as the status of the property taxes for each year. Scroll down to the bottom of the page. There are options to "Pay now," "Make Partial Payments" or "Request Tax Receipt." Below those options will be a grey box that lists the available payment plans for that property and a description of the payment plan. The site will only list the payment plans available for that specific property. To enter into the payment plan, click on the purple box denoting the payment plan.



**Step 6:** A window will pop up with the tax information and owner information. Fill out the requested information on the screen. All fields are required. Once complete, press "Proceed w/Payment."

**Step 7:** When you click the "Proceed w/Payment" button, you will be transferred to a DocuSign portal to complete the E-Signature. Once that is completed you will be redirected to Chase Payment Portal and can make the required payment from your bank account or credit card. If you have any difficulty or choose to pay through a different method, you may make the required payment at a nearby DivDat kiosk which also accepts cash payments, or by using the Wayne County Mobile app. The Wayne County Mobile app can be downloaded through Apple or Google Play and selecting "Pay Property Taxes." You will receive an email from "ERIC R. SABREE Wayne County Treasurer via DocuSign," which allows you to print or download the completed payment plan, and to complete your E-Signature if you did not complete it at the time of enrollment.

Once you have made your final payment and signed the document in DocuSign, the process is complete. You have successfully enrolled into a payment plan!

## Frequently Asked Questions about the March 31 deadline

#### What's the importance of the March 31 deadline?

To be compliant with the Michigan law, the last day to pay your forfeited taxes or enter into a payment plan at the Wayne County Treasurer's Office will be March 31st of next year. The Wayne County Treasurer's Office can no longer extend the property tax redemption period.

## Why can the Wayne County Treasurer's Office no longer extend the property tax redemption period?

A recently completed state audit found that the Wayne County Treasurer's Office was in violation of the law regarding the extension. We therefore can no longer extend the redemption period as we have in previous years.

#### How do I redeem my property from foreclosure?

To redeem your property, you must pay off your delinquent property taxes or enter into a payment plan.

#### What should I do if I cannot pay my property taxes?

You should sign up for a payment plan. The Wayne County Treasurer's Office offers various payment plans to assist taxpayers with paying delinquent taxes. If you agree to a plan, you can have more time to complete the payment of your taxes. You may also be able to get assistance or free legal help from our community partners. Visit our website treasurer.waynecounty.com to enter into a payment plan or to learn about our community partners.

#### What should I do if I have questions regarding payment plans?

#### Can I make partial payments?

Partial payments will be accepted. You can send in whatever amount you wish to be applied to your taxes. If you want to receive a statement reflecting the amount paid as well as the balance due, you must send a self-addressed stamped envelope with your payment.

## Property tax payment plans are available now!

## Interest Reduction Stipulated Payment Agreement (IRSPA)

This payment plan reduces the interest rate from 18% to 6% for eligible taxpayers. To sign up, you must own and live in your home, and have a Principal Residence Exemption (PRE) and ID that proves residency.

## Stipulated Payment Agreement (SPA)

Available to everybody, this plan allows a taxpayer to pay taxes pursuant to a payment schedule. The plan will avoid foreclosure provided that payments are submitted per the agreed upon schedule.

## TAX INFORMATION



### 2019 PROPERTY TAX TIMELINE

Wayne County
Treasurer

Michigan law, Act 123 of the Public Acts of 1999 (MCL 211.78 et seq), establishes the time property owners have to pay their delinquent taxes before losing their property.

**July/December 2019:** 2019 property taxes are billed by city/township treasurer.

March 1, 2020: Unpaid 2019 property taxes became delinquent and were forwarded to the county treasurer for collection. State law requires a 4% administration fee and 1% per month interest.

October 1, 2020: A \$15 collection fee is added to each parcel.

March 1, 2021: Property is forfeited to county treasurer. State law requires the addition of a \$175 fee and \$30 in recording fees. Interest increases from 1% per month to 1.5% per month, back to the date the taxes became delinquent.

October/November 2021: Notice of Show Cause Hearing and Judicial Foreclosure Hearing are personally served upon a property occupant or posted on the property.

**November 2021:** Publication of forfeited properties subject to tax foreclosure on March 31, 2022.

January 2022: The Show Cause Hearings will be held remotely the second, third and fourth weeks of January. In addition to providing an opportunity to show cause why absolute title to the property should not vest in the county treasurer, our interviewers will have contact information for our community partners who may be able to assist you with your issues.

**February 2022:** Zoom Judicial Foreclosure Hearings will be scheduled for the month. The date and scheduling link for the Hearings will be included in the yellow bag packet.

March 2022: Circuit Court enters a judgment of foreclosure. Property owners may redeem their property by paying the taxes, interest, penalties and fees by March 31, 2022 or lose their property.


**April 1, 2022:** Property is foreclosed. Property owners lose all rights. Title to the property passes to the county treasurer.

**September & October 2022:** Foreclosed property is offered for sale at public auction.

## **Tax Payment Options**

## Pay Taxes Online https://pta.waynecounty.com/

The payment site may default to an amount to be paid; if this is not the amount you wish to pay you may delete the number that appears in the screen and insert the amount that you wish to pay. Search for your parcel. Select the "Pay Now" option and follow the Step-by-Step process for the following:

- Electronic debit to a checking or savings account (ACH). Payments made using this service are at no cost to the taxpaver.
- This site is authorized to accept Visa and MasterCard. Taxpayers using this service will incur a service charge of 2.49% of the total taxes paid. The fee is paid to the service provider, not the Wayne County Treasurer.

To avoid delays, please make sure to also mail the payment "coupon" barcode from the bottom of one of our notices with your payment. If your payment does not contain the tear off "coupon" barcode, your payment will be delayed.

Payments postmarked by the last day of the month will be honored as if received on that day. Please note your parcel ID on the check. A receipt will not be provided. Should you require a receipt you must send a self-addressed, stamped envelope with your payment. The parcel ID or address of the property should be written on the back of the envelope.

You may also request a receipt by providing an email address to our website (Pay Taxes Online) and a receipt will then be provided by email. A tax year that has a status of forfeiture requires certified funds only.

## Pay By Phone

(313) 224-5990 Select Option 1

You can now pay by phone by calling (313) 224-5990 and choosing option 1. You will be prompted to create a password the first time you inquire about your parcel, but your information will be saved for any future payments you make by entering your password. You will be given a confirmation number at the end of the call and if you wish to receive a receipt, you can go back to the website and request one in a few days, or you can send a self-adressed stamped envelope to our address.
