1. Update from the Committee to Facilitate a Strategic Planning Process by Committee Chair Roberts and Vice-Chair Tinsley-Smith

Committee Chair Roberts provided an update on the status of the dayretreat to be held on either May 14, 2022 or May 21, 2022. She said that two facilitators were being considered to be a guest speaker.

For the Economics and Housing Committee, Committee Chair Hughes provided comments about Committee Vice-Chair Crawford's recovery due to an injury sustained in an auto-accident. She said that an update regarding funds received from the federal government for housing will be forthcoming. She indicated that she spoke with a Michigan State Representative regarding equal pay for women and a bill that would prohibit employers from using an applicant's previous pay to determine subsequent pay. She indicated that the Committee is working on a resolution regarding the right to counsel for housing.

For the Education and Childcare Committee, Committee Chair Randall indicated that the Committee is set to adopt the National Education Foundation classes for grade six through twelve. Dr. Randall said that a partnership was formed with 313Reads to connect elementary school children. Dr. Randall highlighted the Committee's next step which is to develop a rubric for selecting school district to participate in the named programs.

For the Mental Health Committee, Committee Chair Gater thanked the Women's Commission for participating in the Women's Commission Mental Health Summit. She reported that the Committee is working on a resolution to address the initiatives to privatize Medicare as it relates to the impact on community mental health resource access.

For the Physical Health Committee, Committee Chair Joyner and Vice-Chair Tinsley-Smith were recognized as absent in the meeting. Committee member Cynthia Douglas provided comments regarding the development of a program to address the physical health of women who are residents of Wayne County.

There was a discussion among members regarding future collaboration between the Physical Health Committee and the Mental Health Committee.

Member Gater provided remarks regarding the outcome of the Michigan Women's Commission event.

Member Hughes provided remarks regarding the Women's Economic Recovery Tour.

Member Gater indicated that the Mental Health Summit recording was forwarded to Michigan Women's Commission member Cheryl Bergman.

Vice-Chair Roberts suggested that the activities of the Women's Commission's be posted Facebook page.
