She said she is hoping to coordinate with film director Paula Eislet, to host a screening of her film, "Aftershock."

## 1. Resource Fair Workgroup – Member Dr. Regina Randall

Member Dr. Regina Randall provided a brief overview of the Women's Intergovernmental Resource Fair event, saying that it will be held on April 27, 2023 from 9:00 a.m.-3:00 p.m. at Wayne County Community College District (WCCCD) – Northwest Campus

Discussion among members regarding the cost of hosting the event at WCCCD, and the date and time of the event.

Discussion among members with Commission Counsel, Felicia Johnson, regarding the need to establish a committee for the resource fair.

Vice-Chair Gater said that members met with Commission Chair Bell to present the plan for the resource fair, and that Chair Bell approved the event.

Member Dr. Regina Randall said that the event is targeting women ages 18 and up of Wayne County. The workgroup is planning to arrange the following: job fair; childcare, housing, medical and employment resources; and an employment skills workshop that will provide mock interviews and resume proofing. She said a box lunch will be served.

Vice-Chair Gater said that the workgroup is planning to have medical vans on-site for immunizations, mammograms and OBGYN health checks.

Discussion among members with Commission Chair Bell to rename the fair to Women's Resource Fair.

Discussion among members with Counsel Johnson regarding the procurement process for vendor contracts for the resource fair.

Vice-Chair Gater provided an overview of the structure of the resource fair event planning process.

Member Dr. Regina Randall provided an overview of the volunteers for the committees.
