Ms. Redmond indicated that tentatively the recount for City of Highland Park is scheduled for December 6, 2022 and the recount for the City of Wayne is scheduled to begin on December 7, 2022. Ms. Redmond indicated that a meeting would need to be scheduled to consider the Petition for Recount filed by Mr. Timothy Klepp for the office of Board Member – Grosse Pointe Public School System. The next meeting was scheduled for Tuesday, December 6, 2022 at 9:00 a.m. in the City of Highland Park.
