Agenda item: Approval to conduct the canvass of the August 6, 2024

**Primary Election** 

Chair Riley requested a staff report. Director Mahar reported that Election Day had some locations that had issues with humidity causing the ballots to swell affecting tabulation in some precincts. Voters using pens instead of the ballot marking devices, causing dirty scanner bars, and some reports of workers having to re-boot ICX devices due to screen freezes. All reported issues were resolved by a technician, cleaning or swapping out the tabulator. He further reported there were some issues with transmitting results, so the local clerks were instructed to drive in their cards and paperwork.

He reported on the number of ballots cast throughout the County, the percentage of voter turnout, and reported that there are 3 precincts that are still outstanding. Northville City Pct. 1, results were received a few minutes ago, City of Detroit Pct. 35, the card from the tabulator was corrupted and the department could not access the polling location to obtain the second card from the tabulator. Redford Township Pct. 9, had some issues with tabulating, so this precinct did not report on Election Night, and this precinct will have to be called down to canvass for a retabulation.

Member Boyd, duly supported by Member Woods moved for approval to conduct the canvass of the August 6, 2024 Primary Election. The motion was adopted unanimously by a voice vote.
