He also stated that under state law the role of the Commission in the hearing is to determine whether each reason for the recall stated in the petitions is factual and of sufficient clarity.

Chair Burton asked Thomas Bruetsch, counsel representing the three board members if he had any remarks. Mr. Bruetsch stated that the petition language is not clear, factual and is based in part on a hypothetical and not based on the actions of the members subject to recall.
