## Determination of Clarity – Kathleen Abke, Office of Board Member, Grosse Pointe Public School System

Chair Burton asked Assistant Corporation Counsel Janet Anderson-Davis to remind the commission of its role in making a determination of clarity. Assistant Corporation Counsel Anderson-Davis reminded the commission that their role is to determine whether each reason as stated on the recall petition is factual and of sufficient clarity to enable the officer whose recall is sought and the electors to identify the course of conduct that is the basis for the recall. She also summarized an opinion issued by Judge Levy regarding a determination of clarity in the case of White vs. Wayne County Election Commission.

**Board action on agenda item:** Chair Burton requested a motion regarding item 5A-1. Member Garrett, duly supported by Member Sabree, moved to bring item 5A-1 before the commission for discussion purposes. The motion was adopted by unanimous consent.

Mr. Scott Hughes, attorney representing the petitioner, stated that the language in the petitions are an assertion fact and that it is clear enough to put the public official on notice of the reason for the recall and give notice to the public of the reason for the recall.

Chair Burton asked Thomas Bruetsch, counsel representing the three board members if he had any remarks to offer. Mr. Bruetsch stated that he would like to address the petitions for Abke & Gafa together. Mr. Bruetsch indicated the petitions are intentionally deceptive because the petitions don't state which of the 9 elementary schools are to be closed in the Grosse Pointe Public School System.

Reason for recall as printed on the Recall Petition 5A-1 for Kathleen Abke:

"On June 24, 2019, Kathleen Abke voted in favor of closing two elementary schools in the Grosse Pointe Public School System School District."

**Board action on agenda item:** Chair Burton, duly supported by Member Garrett, moved to approve item 5A-1 as sufficiently clear. The motion was adopted unanimously by a voice vote.
