Reason for recall as printed on the Recall Petition 5A-1 for Susan Evitts:

"Ms. Evitts has violated the code of ethics described in the R.C.S. Board Bylaws & Policies. She failed to honor majority decisions by openly accusing Board Members of dishonesty and deceit. Her behavior has caused the School Board to become dysfunctional and ineffective in serving the needs of the School District and its students."

Board Members are not prepared to deliver factual information to the citizens of Romulus Community Schools, therefore they are misinformed or not informed at all."

When given legal advice she failed to share with the entire School Board Her actions has compromised the School Board and School District."
