ANALYSIS OF CHALLENGE

TOTAL NUMBER OF SIGNATURES QUESTIONED UNDER CHALLENGE: As a result of challenge filed by T.P. Nykoriak, 1,020 signatures are at issue.

Staff has reviewed the challenge submitted by T.P. Nykoriak, and notes that the challenge does not specifically address each signature entry or the basis for the challenge for a specific signature line. The challenger attempts to submit a mass or blanket challenge which does not follow the instructions outlined in the Michigan Secretary of State's guidance published "Petition Manual: Nominating Petitions for Partisan and Federal Offices" pg. 21 sub. B, dated July 31, 2025. The challenge also does not align with MCL 168.552(2).

Aside from the challenge to the petition, the filing does not survive the two-pronged review needed before the signature verification process can proceed. The first review is the preliminary review to ascertain the number of signatures submitted. The second review is the secondary review where staff reviews the filing for any incomplete or improper headers, missing signatures, incomplete addresses,

addresses outside of the electoral district, P.O. Boxes, missing or incomplete date of signing and incomplete or improper circulator certificates.

While staff is not required to proceed further with the signature verification review, it does note that many of the signatures appear to be affixed by the same hand or hands in a process described by the State Bureau of Elections as “round-tabling”. A random spot check of signatures on 10 petition sheets (1, 19, 28, 35, 46, 51, 63, 77, 89 & 92) does suggest that the signatures are forged or fraudulently affixed by an individual not purported to be the elector. See attached examples.

Petition 000001 – Line 7 is purported to be signed by Samuel Davis Jr. at 14574 Vaughn St., Detroit, MI 48223. Line 8 is purported to be signed by Sarah Davis residing at the same address, however, the signature on line 8 bears the suffix of Jr., which is not found on the voter’s registration. All signatures on Petition 000001 appear to be signed by the same hand and the pattern continues throughout the entire set of petitions. Misspelled names, different first or last names, first and middle name with the last name omitted, same or similar handwriting style, flourishes, slants, and swirls.

Petition 000028 – 000033 – All signers purportedly reside at 6309 Mack Ave, Detroit, MI 48207. A google maps search indicates the property is registered as “Team Wellness Center”. A check of the Qualified Vote File shows many of the signers who reportedly signed petition sheets 000028 – 000033 have not resided or utilized this facility as a mailing address dating back to 2019. Many signers are registered at a different address or outside of the 13th District.

The pattern continues throughout each petition page displaying examples of round tabling and blatant forged and fraudulent signatures.
