Approval of the 2002 County Equalized Valuations for the Charter County of Wayne; the Assessment and Equalization Division of the Department of Management and Budget reports that the assessment rolls of the various Wayne County cities and townships have been examined for the purpose of determining any adjustments which may be required for the county equalization of assessments as required by Section 34 of the General Property Tax Act; the total recommended equalized value of the County of Wayne for the 2002 assessment and tax year is \$53,800,509,901; this sum represents an increase of \$4,753,565,862 or approximately 9.69% above the total county valuation for 2001; it is recommended that \$8,077,598 and \$2,540,984 be added to the total personal property assessed valuations for the Township of Brownstown and the City of Gibraltar, respectively; both communities continue to inequitably and non-uniformly assess utility personal property at a valuation level below that found in any of the other forty-one Wayne County communities.
