REPORT FROM THE CHAIRWOMAN

CHAIRWOMAN WARE: "I still have a few goals out, so to our Committee Chairs please

turn in your goals as soon as possible. If we can have those goals by tomorrow, we would greatly appreciate it because we're working on the budget and we're also working on our Legislative Agenda.

I just want to take a moment to say that today we're going to honor one of our very own. Today, is April 3rd, but on April 6, 1978 Commissioner Kay Beard was appointed to the Wayne County Commission and today we're celebrating her 25th anniversary on the Wayne County Commission. In the past 25 years she has represented Inkster, Westland, Garden City, Dearborn Heights, and now she represents a part of Livonia. Commissioner Beard lived in Inkster for 40 years, and just recently, I guess, she moved to Westland, Michigan. She started originally with this Commission, and at that time I believe we called it the Board of Commissioners.

We just want to take a moment to say that we really appreciate your dedication to your constituents and to this Commission. Commissioner Beard, on behalf of Wayne County Government, we have a pin for you and it has three rubies in it. The pin represents 25 years of service with Wayne County. Your Mayor Pro Tem is here with you today from Inkster, Wanda Harris Foster and your City Council person, Lorenzo Moner."

COMMISSIONER BEARD: "I would like to thank everybody. This has been a long and eventful 25 years. It's hard to believe that it's been that long but at the time that I was appointed, the district was all of Inkster, everything in Dearborn Heights south of Ford Road, and seven precincts in Westland. Some people said, "well, she's just keeping the seat warm, she'll never be elected". Well, 25 years and 13 elections later, here I am. I thought I had seen it all until what happened with the resignation, and an attempt to withdraw, and those court procedures that went on. That was brand new. So I guess there is always something new under the sun.

It's been a fantastic 25 years with all the amazing things I have done, and all the many trips to the White House, especially the three on St. Patty's Eve for parties, bill signings in the Rose Garden, and announcements in the Blue Room. I was in leadership with NACo and chaired a committee, things that I would have never dreamed of doing in my lifetime; getting to know the President; getting to know top elected officials, Senators and Congress people. It's amazing.

I was just a housewife raising my kids when I started getting involved in an issue and the issue led me into politics and here I still am. I have enjoyed working with each and every person that I have worked with. I'm the only one left from the 27 member board and I am the only one left from the original 15 member board. I'm a dinosaur, but I had a good time. As Jewel said, I try to keep people on time and I particularly have tried to make us be more professional in the way we report our dealings and our committee reports. It looks like I have to start cracking the whip again because I see that we have some new people that are not using the kinds of formats and type faces and forms that need to be used. As I was going through the agenda last night I thought, "oh boy, here I have to start all over again, we have a

whole new crew". But, government is very important. We impact on what happens to people and we need to have accurate records, and we need to have records that are kept in such fashion that people can understand them when they access them and read them. They may not understand why we did what we did, but at least they will understand what we did. I hope that we can continue to always do that, make ourselves accessible to the people who vote for us and that's what I try to do. My reputation has been that I'm around and I try to get to everything I can so that people know who I am in the area that I represent. You know that I am not shy when it comes to speaking up about things that I think are injustices, and there is still a lot of injustice in this world and there is a lot of injustice going on overseas right now. A lot of people are being killed unnecessarily because they get in the way of bullets that are flying around. We're going to need a long time in this country to try to repair some of the problems that are developing around the world and our dealings with people.

This was a wonderful surprise and I want to thank each and everyone of you. We don't always agree on everything but I think we never get really disagreeable, we get a little bit loud sometimes but I think when the meetings are over we're all still friendly, and that's really what we need to be as good responsible, productive public citizens and public servants. So, thanks to everybody that's here and thanks for all of you for working with me all through the years and putting up with my goals of trying to make us as professional as possible, because we need to do that. Thanks again."

CHAIRWOMAN WARE: "Today at 3:00 o'clock on the 4th floor we're going to have a desert celebration in honor of Kay Beard's 25th anniversary. Everyone is welcome".
