Dated April 5, 2004 (received June 18th) requesting Commission approval of a sole-source contract between the Charter County of Wayne and Legion Industries, Inc. (of Waynesboro, GA) in the amount of \$9,428 to replace four 55 gallon stainless cooking skillets for the Wayne County Sheriff Food Services Division; the CEO advises that the Food Services Division purchased four, 55 gallon skillets in 1998, to be used in the preparation of 4,500,000 meals annually for the Jails/Youth Home and 910,000 meals annually for the Senior Nutrition Program; due to intense and extreme usage, these skillets must be replaced, and Legion Industries is the manufacturer of this equipment, therefore a sole-source designation is requested; Legion will replace two skillets at no cost and provide two additional skillets at a 50% discount (\$4,714 each); the cost of the contract will be charged to Account No. 101 35105 742000 (Jail Food Svc). Dated June 11, 2004 (received June 30th) requesting Commission approval of a proposed amendment to the 2003-2004 Appropriations Ordinance (Enrolled Ordinance No. 2003-617) in accordance with Budget Adjustment No. 04-35-250 reallocating appropriations to certify additional revenue of \$25,000 in the Law Enforcement Fund (266) and to reduce revenue in the amount of \$25,000 in Central Services (635); the CEO advises that from July 1, 2002 through September 30, 2004 the U.S. Department of Justice, Office of Justice Programs awarded the County of Wayne program funding for the "Wayne Area Justice Information System" (WAJIS); the Department of Technology was originally appropriated \$500,000 from the grant for the GIS Street Centerline project, and is transferring \$25,000 to the County Sheriff operation to support the purchase and refurbishment of an emergency response vehicle; this grant requires no local cash. Dated March 23, 2004 (received April 7th) requesting Commission approval of a proposed amendment to the 2003-2004 Appropriations Ordinance (Enrolled Ordinance No. 2003-617) in accordance with Budget Adjustment No. 04-35-133 certifying additional revenue of \$338,586 in the Mental Health

Fund (222); the CEO advises that the Detroit-Wayne County Community Mental Health Agency has realized additional revenue resulting from an increase in the annual Children's Waiver Program totaling \$338,112, and an increase in the annual Comprehensive Services Program of \$474; the adopted budget included an estimate of \$2,432,465 for this revenue source and the additional \$338,586 is the net increase between the budgeted amount and the amount actually granted from the Michigan Department of Community Health; this revenue was not anticipated when the 2003-2004 budget was adopted. Dated April 15, 2004 (received April 23rd) requesting Commission approval of a proposed amendment to the 2003-2004 Appropriations Ordinance (Enrolled Ordinance No. 2003-617) in accordance with Budget Adjustment No. 04-35-200 certifying an increase in revenue in the amount of \$141,000 in the County Health Fund (221); the CEO advises that this revenue represents additional funding from the Michigan Department of Community Health for the Women, Infants and Children Program operated by the Health and Human Services Department of Public Health; MDCH increased the WIC caseload for Public Health from 11,900 participants to 13,500 participants and has granted Public Health additional funding to cover the costs associated with the increased caseload; these funds were not anticipated when the 2003-2004 budget was adopted. Dated April 15, 2004 (received April 23rd) requesting Commission approval of a proposed amendment to the 2003-2004 Appropriations Ordinance (Enrolled Ordinance No. 2003-617) in accordance with Budget Adjustment No. 04-35-078 certifying additional revenue of \$1,400,000 in the Community Development Block Grant Fund (275); the CEO advises that the County has been approved for a Section 108 loan on behalf of the City of Hamtramck as partial funding for the Grand Haven/Dyar project; the Commission as well as the Department of Housing and Urban Development has approved this loan (Resolution No. 2003-895) and Hamtramck has agreed to repay this loan beginning August 1, 2004; repayment of the loan is guaranteed by the CDBG HUD funds that are available to the City every year, and an indemnity

agreement has been signed holding the County harmless in the event that Hamtramck defaults on the loan; the County has also been approved for a Brownfield Economic Development Initiative Grant on the City of Hamtramck's behalf as partial funding for the same project, and the Section 108 loan is a pre-requisite to the BEDI grant award; by approving the loan, HUD allows for this grant to be awarded. Dated April 14, 2004 (received July 14th) requesting Commission approval of a proposed amendment to the 2003-2004 Appropriations Ordinance (Enrolled Ordinance No. 2003-617) in accordance with Budget Adjustment No. 04-35-034 certifying an increase in revenue in the amount of \$37,070,351 in the General Fund (101); the CEO advises that in October 2003, the Wayne County Health and Human Services Division of Patient Care Management Services (PCMS) entered into an agreement with the Michigan Department of Community Health (Resolution No. 2003-802) to administer the Adult Benefit Waiver program (formerly the PlusCare program); there are approximately 27,000 members enrolled in the ABW program, and PCMS receives \$118.54 per member/per month to administer the program, consisting of \$110 per member/per month paid to ABW service providers, and \$8.54 per member/per month retained by PCMS as its administrative fee; total anticipated funding for the ABW program for the 2003-2004 fiscal year is \$38,406,960, consisting of \$35,640,000 for service provider payments and \$2,766,960 for PCMS administrative fees; the PCMS 2003-2004 budget was prepared before the dissolution of the relationship between Wayne County and Urban Hospital Care Plan (UHCP) and

anticipated an administrative fee of \$1,505,000 from UHCP; PCMS is only certifying an additional \$1,261,960 for its administrative fee, resulting in a net certification of additional revenue for the ABW program totaling \$36,901,960; in addition to the MDCH funds, PCMS is certifying additional revenue of \$168,391 that represents a 3.5% administrative fee for the HealthChoice program previously administered by UHCP, and currently administered by Metro Health Care; these funds were not anticipated when the 2003-2004 budget was adopted. Dated June 11, 2004 (received June 30th) requesting Commission approval of a proposed amendment to the 2003-2004 Appropriations Ordinance (Enrolled Ordinance No. 2003-617) in accordance with Budget Adjustment No. 04-35-215 certifying additional revenue of \$257,800 in the Law Enforcement Fund (266); the CEO advises that the Michigan Department of Corrections has amended the original intergovernmental agreement with the County to reflect changes related to the contract durations, amount and contractor for the Parole Absconders operation; the contract was modified to extend the contract period from May 1, 2000 to September 30, 2004 and the amount increased by \$209,000, from \$2,000,000 to \$2,209,000; concurrently this amendment changed the contractor for the County from the Department of Community Justice/Children and Family Services to the Sheriff's Department; in addition the Sheriff is reallocating current appropriations in order to fund an additional \$48,800 to cover this operation through the end of the fiscal year. Dated March 17, 2004 (received July 9th) requesting Commission approval of a proposed settlement in the matter of Darrell Wayne Martin vs. Wayne County, et al (Case No. 02-74866) in the amount of \$65,000; the CEO advises that the Plaintiff was an inmate at the Wayne County Jail, who arrived with prescription medication for a seizure disorder, and requested a lower bunk; the Plaintiff did not receive his medication or a lower bunk; Plaintiff suffered a seizure and fell off the top bunk, sustaining multiple injuries including a fractured pelvis, broken wrist, a torn anterior cruciate ligament in his knee and several lost teeth; Wayne County has policies and procedures for accommodating an inmate with a reported seizure disorder and administering medication, however these policies may not have been followed in this case; given the nature of the injuries and the claims involved, it is in the best interest of Wayne County to settle this lawsuit for the amount of \$65,000; the proposed settlement will be paid out of Account No. 101 92501 911140 (Liability Payments). To Committee on Government Operations 7/14/2004 Dated June 14, 2004 (received July 1st) requesting Commission approval of a settlement between the General Motors Corporation and the Charter County of Wayne in the amount of \$500,000 in in-kind services to be performed by GM; the CEO advises that Wayne County undertook a project to restore Newburgh Lake as a recreation and habitat resource, and to remediate contaminated sludge that had settled to the bottom of Newburgh

Lake; as part of the project, Wayne County discovered PCB contamination in the sediments removed from various locations throughout the lake, and alleges that materials containing PCB's and other contaminants were discharged into Newburgh Lake via a sewer outfall, including some material from the GM Livonia Facility; under the proposed settlement agreement, the County will release GM from liability in exchange for \$500,000 of in-kind services for improvements to Newburgh Lake; it is recommended that this matter be settled due to the additional cost of litigation, the County's interest in limiting its' exposure to liability, and the reasonable settlement amount; the settlement agreement contains no admission of fault or liability on behalf of the County of Wayne or any other party; Azzam Elder, Corporation Counsel, Joe Nardone, Director of Parks, and Cameron Priebe, Director of Department of Public Services were consulted and concur in this settlement.
