- H. Report from the **COMMITTEE OF THE WHOLE** recommending the following:
 - 3. Approval of an Ordinance to amend the Wayne County Code of Ordinance to establish the ordinance to eliminate smoking in public and private worksite and public places, not including bars, restaurants, bingo halls, and casinos; and to provide penalties for violations of these prohibitions. (2003-68-006)

Commissioner Beard, supported by Commissioner Parker, moved approval of foregoing Report H, item 3 and adoption of the ordinance.

During discussion, Commissioner Williams offered Amendment No. 1 to delete the following language: Page 9, Lines 8-10, Section 178-13. Violations and Penalties.

A FINE NOT EXCEEDING FIVE HUNDRED DOLLARS (\$500) AND/OR UP TO 90 DAYS IN JAIL FOR A THIRD VIOLATION WITHIN ONE YEAR FROM A PREVIOUS VIOLATION.

Commissioner Beard, supported by Commissioner Parker, accepted Amendment No. 1 as a friendly amendment. Therefore a voice vote not being required, Chairwoman Ware stated the amendment was now included in the Ordinance.

As discussion continued, Commissioner Varga offered Amendment No. 2 to insert additional language as follows: Page 7, Section 178-9. Where Smoking is Not Regulated.

(6) A DESIGNATED SMOKING ROOM WHICH IS TOTALLY SEPARATE FROM THE REMAINDER OF THE WORK SITE, WHICH HAS A SEPARATE HEATING AND VENTILATION SYSTEM WITH A NEGATIVE AIR PRESSURE, SUCH THAT NO SMOKE ESCAPES EVEN WHEN THE PASSAGEWAY INTO THE ROOM IS OPEN. BUT ONLY IF THE ROOM HAD BEEN CONSTRUCTED AND EQUIPPED PRIOR TO APRIL 1, 2004.

Commissioner Beard, supported by Commissioner Parker, accepted Amendment No. 2 as a friendly amendment. Therefore a voice vote not being required,

Chairwoman Ware stated the amendment was now included in the Ordinance.

As discussion continued, Commissioner Hubbard offered the following additional language as Amendment No. 3 to Section 178-18. Effective Date.

"THIS ORDINANCE SHALL BE EFFECTIVE NINETY DAYS FROM THE DATE UPON WHICH THE STATE OF MICHIGAN PROVIDES AN APPROPRIATION FROM THE TOBACCO SETTLEMENT FUNDS TO WAYNE COUNTY TO SUPPORT ENFORCEMENT OF THIS ORDINANCE. "

Commissioner Beard, supported by Commissioner Parker, did not accept Amendment No. 3 as a friendly amendment.

Commissioner Hubbard, supported by Commissioner Boike, moved approval of Amendment No. 3.

"THIS ORDINANCE SHALL TERMINATE TWO YEARS AFTER THE EFFECTIVE DATE. DURING THE INTERVENING PERIOD OF TIME, THE DIRECTOR OF HEALTH AND HUMAN SERVICES SHALL MONITOR THE NUMBER OF VIOLATIONS OF THIS ORDINANCE AND REPORT TO THE WAYNE COUNTY COMMISSION ON THE OUTCOME OF SUCH VIOLATIONS.

IF THE WAYNE COUNTY COMMISSION DETERMINES THAT IT IS GOOD PUBLIC POLICY TO CONTINUE THIS REGULATION, A NEW ORDINANCE WILL BE REQUIRED."

Commissioner Boike, supported by Commissioner Varga, moved approval of Amendment No. 5 as a friendly amendment.

Following continued discussion, Commissioner Boike, supported by Commissioner Varga withdrew Amendment No. 5.
