INVOCATION

REPORT FROM THE CHAIRWOMAN

COMMISSIONER WORONCHAK: "I would like to bring to the attention of my colleagues the passing of Mayor Michael A. Guido, a great leader in Dearborn and a great friend to me. The Mayor was diagnosed with cancer less than a year ago and fought a good fight but unfortunately lost that fight on Tuesday at the age of 52, very, very young but so many accomplishments in so few years. He served as Mayor of Dearborn for 21 years. His first year of his sixth term, two of the terms he ran entirely unopposed in a city that is known for it's political competitiveness. Not only did he serve 21 years as our Mayor, he served eight

years on our City Council before that. So, 29 years of public service at age 52 is truly remarkable. He'll be remembered for his great sense of humor and for his great sense of duty and commitment to the city that he loved. He was certainly well respected throughout Wayne County, in fact throughout the nation. He was elected just this past June, the President of U.S. Conference of Mayors, so his abilities ran on far beyond just the City of Dearborn. He leaves behind his wife, Carrie and his two sons Michael, Jr. and Anthony. And I ask all of you to remember Mayor Guido and his family in your prayers."

- COMMISSIONER PARKER: "I would like to echo those comments but also say that he was one that I had developed great respect for. He took over as Mayor in a city that at one time had a lot of challenges around diversity and racial issues but he was the one that stepped in and really believed in diversity and trying to work together as a total Southeastern Michigan, particularly black and whites together. I've had a number of meetings with him around that area and served on committees with him. He has even visited Operation Get Down when I was there. So I really think that it's a great loss for us all in Wayne County and for the whole region and I send my condolences to his family."
- CHAIRWOMAN WARE: "I too think it's a great loss for Wayne County. Every time I had an opportunity to be with the Mayor when I was invited to Dearborn or when we were in other meetings, he always kept an open heart. When I was watching television just the other night when they were interviewing his constituents, one lady from the school with her children, spoke on the way he communicated and reached out to people. He will be greatly missed and we are going to keep his family in our prayers."
- COMMISSIONER P. CAVANAGH: "I would just like to echo the settlements of my colleagues in representing Dearborn Heights. I ran into Mayor Guido several times but at the NACO, National Association of Counties this past summer in Chicago he was one of the keynote speakers at the convention because he was President of the Conference of Mayors. I just remembered how he had a room full of probably five thousand County Commissioners from around the country in stitches. He had a great sense of humor. He conveyed the message about how cities and counties had to work together for progress of our country and he worked until his final days. He'll be missed."
- COMMISSIONER BEARD: "I've been knowing Michael during his whole 10 years as Mayor and he was always a fun person to be around. He had a great sense of humor and nobody loved the City of Dearborn more than Michael Guido did. He was totally devoted to the city. He worked 12 and more hour days all the time, but he was never too busy to talk to people and listen to his constituency, and that was one of the hallmarks of his 10 years as Mayor that he listened to the people so that he knew what was going on. I was terribly shocked when I heard the news. I knew that he had cancer. I saw him two or three weeks ago and he had lost a lot of weight but he was very upbeat. He was sure that he was going to beat it and he was sure he was going to be around for a long time, but the Lord saw otherwise. I'm sure he will rest in peace knowing that he did his best throughout his life time."

COMMISSIONER P. CAVANAGH: "I just want to announce that in my district we also lost Edward Plawecki, who is a former Commissioner. Funeral arrangements will be at the Santeiu Funeral Home on Inkster in Garden City. Viewing will be Friday from 2:00 p.m. to 9:00 p.m., with prayer service at 7:30 a.m. followed by a mass funeral service Saturday at 10:00 a.m."

COMMISSIONER BEARD: "Former Commissioner Edward Plawecki had been one of my mentors early in my career when I first became a Commissioner way back in 1978. He and I were very good friends along with several other people that were involved in Democratic Party at that time. When I was first a Commissioner, before we became a Charter Commission, I had half of Dearborn Heights in my district, I had everything south of Ford Road along with all of Inkster and seven precincts in Westland. Edward always wanted the opportunity to serve as Commissioner. He was a great guy, a great Democratic Politician, and a wonderful father. His son Eddie was on the Commission with us and Michelle, for a while. These are hard days when you lose friends of many years and Edward was certainly one of the top people in the UAW and one of the top Democrats in Western Wayne County and we will miss him as well."

At this point in the proceedings, Chairwoman Ware requested everyone to stand for a moment of silence in honor of Mayor Michael Guido and Edward Plawecki.
