#### REPORT FROM THE CHAIRWOMAN

CHAIRWOMAN WARE: Peace and blessings to each and every one of you and thank you for joining us today. I would like to take a moment of silence in honor of our former president Gerald Ford. Thank you.

I know I've done this a couple of times before and each time I do it, it has a different meaning to me and of course today has a different meaning to me. To my colleagues I would like to say that I am honored and humbled by the re-election by each of my

colleagues for your confidence, and your faith, the support that you give me means so much to me.

I would like to take this opportunity to thank our partners who have joined us today. Our County Executive, Robert Ficano; our Register of Deeds, Bernard Youngblood, and again we want to take this opportunity to thank our Clerk for being with us today Cathy Garrett, our Sheriff, Warren Evans. We have many representatives from our Mayor's office from the City of Detroit. Mayor Kwame Kilpatrick, I thank them for joining us today. Councilmember Kwame Kenyatta, I hope I haven't missed anyone. I don't know if he arrived yet and I know that he is also a very busy person but I need to always mention him and thank him for his guidance and the time that he has given me and that is our former Chair of the Wayne County Commission, Art Blackwell and his dad who I affectionately call "Daddy Bob," Robert Blackwell. I hope I haven't missed anyone. I am a member of Genesis Lutheran Church and the invocation given today was by my Pastor, Skip Wachsmann.

Being chairperson of the Wayne County Commission is a huge responsibility, and it 's one I do not take lightly. I have been entrusted with providing the leadership and oversight of the County's Legislative body. This body must uphold the County Charter, set policy and provide financial accountability for the taxpayers of Wayne County.

To our 11 returning Commissioners, thank you for your cooperation and participation during our previous term. We accomplished much during trying times. We have faced the worst economy Wayne County has encountered in decades. But we are weathering the storm, keeping layoffs and service cutbacks to a minimum.

Your hard work and attention to the bottom line have been very valuable to me and to the county.

To Tim Killeen and Kevin McNamara I extend a warm welcome to our Wayne County family. Each of you bring special talents and career experiences that will impact our legislative body in a big way.

Our challenges for the coming 2007-2008 legislative session are many. As the Chair of the Commission, my agenda for the coming term includes the following:

The Wayne County Commission must weigh in and play a key role on several

important regional projects, including public transit, a new international border crossing and working with the City of Detroit to improve Cobo Hall. Everybody knows I am big about mandated services. We cannot and we will not ignore our key function. And that is making sure Wayne County delivers charter services like public safety and criminal justice.

Challenging times demand creative thinking. Wayne County has always been a leader in new concepts like Health Choice, juvenile justice, and the Rouge clean up. These programs have all served as national models. In 2007, the Wayne County Commission will research "best practices." We will look for new programs that could work here.

Our County continues to face shrinking revenues and flat economic growth. Yet our expenses continue to climb. The Wayne County Commission must find ways to cut costs and stretch dollars. We will explore partnerships with local communities, state and federal agencies and foundations to seek new funding.

The Wayne County Health Authority has been a great disappointment. It has not provided health care to the uninsured and underinsured. I recommend we work with the city and the state to reorganize how we provide health care to this population. One concept is to find resources for doctors to operate clinics in the neighborhoods for the people.

Our County Executive Robert Ficano has taken creative approaches on China trade, Regional Justice, TURBO and other initiatives. We encourage his team to continue to look for new approaches and programs to benefit Wayne County.

We also salute Mayor Kwame Kilpatrick for his new neighborhood program, and we look forward to being a partner on this activity.

Clearly, we have a full plate in the coming months health care, economic development, public safety, mental health issues and public services. Our agenda will require teamwork and partnership.

Wayne County has many strengths. Wayne County has tremendous diversity. Wayne County has a strong work ethic. Wayne County has many resources. Let's build on these assets.

As we move forward, we must remember our constituents: the two million residents of our 43 communities. They elect us to safeguard their tax dollars, protect their interests, and improve their quality of life. We don't want to disappoint them or let them down. So let's get to work and make Wayne County better! God bless you."
