F. Report from the <u>COMMITTEE ON PUBLIC SAFETY</u>, <u>JUDICIARY AND HOMELAND</u> <u>SECURITY</u> recommending the following:

1. Approval of a retroactive grant contract between the Charter County of Wayne and the Michigan Department of Natural Resources in the amount of \$30,000 for the Sheriff's Department; this funding provides for Off Road Vehicle Safety Education provided through the Marine Safety Unit, at the rate of \$20 per student; the term of the grant is from October 1, 2007 through September 30, 2008; the revenue from the grant will be deposited into Account No. 101 33100 631080 (Sheriff-Marine Safety). (2008-71-005)

- Approval of a grant contract between the Charter County of Wayne and the Michigan Department of Corrections in the amount of \$2,554,629 to continue local PA 511 programs and services to improve jail utilization and reduce the prison commitment rate; this grant provides for various treatment services and other non-incarceration alternatives; the term of the grant contracts from October 1, 2007 through September 30, 2008; the revenue from the grant contract will be deposited into Account Nos. 281 32000 543000 (\$2,534,629-Community Corrections) and 281 51085 543000 (\$20,000-Alternative Work Force).
