At this point in the proceedings, Wayne County Clerk Cathy Garrett relinquished the Chair to Chairman Edward A. Boike, Jr., who gave the following remarks:

REPORT FROM THE CHAIRMAN

CHAIRMAN BOIKE: "To our Wayne County Clerk, Cathy Garrett, it's always a pleasure to have her here and whenever we get an opportunity to see her we are thankful. Cathy thank you very much. We also have standing in is County Executive Bob Ficano. All elected officials, not including the Commissioners, will you please stand to see everyone that is here? The Treasurer of Wayne County, Ray, just wanted to say "hi" and we don't need any money yet.

This is great and it's just been great to see all of the swearing in's today with all the loved ones and all the friends. Acknowledging Art Blackwell who was a past Chairperson I believe in 1989, our Attorney General, and all of the judges. It is great to see you.

Commissioners, it is truly an honor to be selected Chairman of the Wayne County Commission by my colleagues and I know you have put me in a position of putting your faith and trust in me and I promise that I am not going to let you down. The job of Chairperson is a major responsibility. I know and understand that and it is a huge undertaking. Some of the research that I've been doing with your help and you can certainly see what is ahead of us. I have been entrusted in providing the leadership and oversight of the County's Legislative body. I do not take this lightly. I will work to uphold the Wayne County Charter as we took the oath today several times, set policy, and provide financial accountability for the taxpayers of Wayne County, but it's with your help. I'm going to be calling on you, for a lack of a better word, a whole bunch for help and assistance.

To our two new Commissioners, Diane Webb and Joan Gebhardt, I'd love to extend a warm welcome to the Wayne County's 2009-2010 Legislative Session. What's been nice about the Commissioners, our two newest ones, when they were Commissioners-elect, they attended a lot of our Rules meetings and other meetings. So I know they are prepared when we get into part of the business today.

At our last Commission meeting we took a bold step and we passed temporary new rules and you are all going to view on today something that we've never done before, but we are going to save that as a treat at the end. It's the blind draw that we had talked about in the policy board. In the days and weeks ahead we will look at how we can put new policies and procedures at the Commission. Just as the automotive industry is reinventing itself, Wayne County government must change the way it operates. One of my key priorities is to streamline the County Commission, again with your help. We will have to find ways to work more efficiently and effectively. We have a very talented and dedicated team of employees but we need to make sure they work with more structure and order. We will give them the tools and the training to perform their jobs more productively. We all know Wayne County is currently enduring one of its worst economic downturns since the depression. Experts say its even going to get worse, unfortunately, Bob. Our challenge is to minimize the reduction in services and programs we provide our citizens and communities. Wayne County has 43 separate and distinct municipalities. Each with their own unique challenge and our task is to balance the needs and the resources available to all 43 communities and be attuned to their needs, but we must seek additional funding sources to improve roads, maintain drains, fight foreclosures and develop underutilized properties. Of course, the common denominator is that all communities need jobs. legislative branch of county government we will work with County Executive Bob Ficano and his staff to diversify our economy, create new employment, and generate additional tax base for our county and our communities. We are facing tough times. No question about that, but this is a County that put the world on wheels. We're the ones that defend liberty at its' darkest hour.

On election night President-elect Barack Obama said: "We have never been a state of red states and blue states. We are and always will be the United States of America." We can borrow that and bring it to the County and that statement applies to Wayne County and we are not a County of city and suburb. We are one Wayne County. We can emerge from this current storm by being strong and united like I've seen time after time and had the honor to work with members of this Commission. I'm calling on you my colleagues and you might get sick of me calling you and asking your advice, but you won't. I know everybody on this Commission. I am calling on you my colleagues to join me in tackling the challenges we face with the same resolve and spirit that you have shown time and time again. These traits define Wayne County. We are Wayne County. All united. Detroit is our county seat. We are 43 communities and I am looking so forward to working with you all and again I'm going to be asking a lot for your help. We'll have committees all assigned and will get into business very, very shortly. Thank you all so very much."
