REPORT FROM THE CHAIRMAN

CHAIRMAN BOIKE: "I'd just like to take a little bit of time today and probably going to echo pretty much what my friend Moe Blackwell said. I have been a recipient of those over the years in my district, as a legislature, as a Commissioner. He has been before this body and made some comments about me and that's certainly his right and I've been in politics for 30 years and I guess that is what we get paid for. If you want to beat up on us that is certainly your right but I just want to say that I couldn't sit here and not comment on the personal attacks on my good friend to my left. I think these attacks go beyond good government. I've know Keith for a long time and in fact he was a pain in my butt years ago when I was a legislature but we've since become very good friends. He is a politician that has an incredible amount of passion and love for his constituency. He does his work. He does his homework. He is the Vice-Chair of this Commission and if God willing when Chairman Boike decides to pass the mantel, Keith will be our next Chair and once again we will have a black Chair in this county, God willing. I am just bothered by the personal attacks on him. I feel that when you attack one member of this body, you attack all members of this body. I mean this from the bottom of my heart, Brother Keith, if Detroit had more politicians like Keith Williams in this town, with your passion, love, respect, honesty and charm, this town would not be in the hell whole that it's in."

COMMISSIONER WARE: "I noticed that Commissioner Leland said that when one of us are under attack, we are all under attack. I don't feel like that. Last year it was a lot going on and nobody stood up to help me, one. Two, I am still under attack and I'm still being harassed. Last week, Tuesday, June 9th they passed out my husband arrest record, somebody that has been in prison 20 years ago. So is that attack? Are you under attack? Is that the whole Commission or is that just me? I am still being harassed and no it isn't when one person is under attack, we are all under attack. Keith happens to be your "road dog" and that's fine. I respect all my colleagues regardless of how they treat me but I want this audience to know that I'm being harassed and I'm being attacked. My husband is a good man and an example for all. How many people do you know that can go to prison and come back and not return."

COMMISSIONER BLACKWELL: "Thank you Mr. Chair. I'd just like to say to all those in attendance, the community folks, Minister Shabazz, to folk that represent District 3, I really appreciate you guys coming out and to Mrs. Hammer, you guys didn't have to come out today. I know that many times it is very difficult to come downtown and pay for parking so I am happy that my colleagues agreed to allow me the ability to host it here. Hopefully, I think we may have a few snacks left and get some food, but I definitely appreciate you guys coming out."

VICE-CHAIR PRO TEMPORE VARGA: "Thank you. You have watched my grandson grow probably for the last twelve years, some of you. Today in the audience it's his first time out of school Josh decided he wants to attend a meeting with me again today and I feel sorry for him because he is going to be in budget meetings after this one. He is shadowing Grandma today and I am so very proud of him that as young as he is he has been doing this since he was nine months old with Grandma. I hope that one day that we can all lift each other and I hope that when Josh gets to be my age that we will worry about everyone making it to the top and not tearing each other down but lifting us all up. Thank you very much."

COMMISSIONER GEBHARDT: "At our last meeting under remarks I said, "Let's Go Red Wings" and it was right before the final game in Detroit even though it was a very difficult, emotional game for all of us as it was I'm sure for them. I'm proud of our Red Wings. I'm proud of the way they handled themselves. I'm proud of our coach and the remarks he made and how he congratulated the other players and so again "Let's go Red Wings!" We will get them next year and "Let's go Tigers, now!"
