REPORT FROM THE CHAIRMAN

CHAIRMAN BOIKE: "I forgot this last month and we have already gone past the 3rd but Happy Birthday to Gary Woronchak. Interesting to the Boike family and I'm sure it means something to us, but my father-in-law passed away eight years ago and he was 92. So as my wife and I got up this morning she did have a little bit of tears in her eyes because this will mark an anniversary of her father and my father-in-law who was born on May 6, 1910. So today he would have been 100 years old. You've all been through that or will be when that so-called magic number is hit so that is what is occurring in my family today.

It's Spring and we get to watch the kids play baseball and get out and play. I get a sun tan and I sit in those folding chairs and it takes all my effort to get out of them. I am walking again and I am getting there four hours at a time. Baseball season is in full gear and of course the Tigers are doing well. The Red Wings are a little shaky at this moment, but for goodness sake it has been done before and twice in the NHL that a team down three to nothing has come back. My grandson was drafted into the Ontario Hockey League, the London Nights and London is a nice little town. He is waiting also for the American League draft. Does anybody have their grills going yet? We have more to celebrate on this day also. Our own Wayne County Commissioner, Diane Webb, was recognized on April 23rd by the Senior Alliance with its' legislative award which is given to elected officials who have contributed to improving the lives of older adults in the region. Everyone knows Commissioner Webb and that with seniors it is a top issue for her. This award is richly deserved, Diane and once again congratulations. What was interesting about it is that it was brought to me by another Commissioner. That is great and I love the family working together.

Chairman Boike requested all to stand for a moment of silence in honor of the foregoing individuals, following which he declared the Resolutions in Memoriam adopted.

REMARKS BY MEMBERS

COMMISSIONER LELAND: "I was just going to piggy-back on to what Keith was talking about. I just want to say that we have a tremendous amount of rental properties in Detroit and probably close to half of those properties are a nuisance. There needs to be a better job with the police and the prosecutor to try and get some of these homes under forfeiture because if there are illegal activities going on the people have a right to get that house back under the forfeiture laws where a lot of the drug activity is going on and I would like to see that process somehow sped up so we can actually shut down some of these houses and take the houses away from the landlords that allow this illegal activity to go on. I've got a couple of more comments but did you want to say something to that Keith?"

VICE-CHAIR WILLIAMS: "I think those houses need to be torn down and now I hear that we are getting ready to get rid of the Nuisance Abatement Department which has been very effective in my communities. Going out to the homeowners and making sure they do something with those properties but I'm telling you that there are a lot of gang activities and a lot of drug activities in those houses. I know that in some of the other communities they don't have those type problems but that is a major problem in the City of Detroit and I take my hat off to administration. They put forth that five million dollars into the city's budget to help with that problem and we don't need to be getting rid of Nuisance Abatement at this time."

COMMISSIONER LELAND: "What I am saying is that the whole forfeiture process needs to be accelerated. I don't know if it's just a lack of personnel or if the forfeiture law needs to get changed but these houses continue to operate as drug dens and other activities go on."

COMMISSIONER GEBHARDT: "I just want to make a comment about SEMCOG and let my fellow Commissioners know about this "diamond in the rough" if you will. I hope that not only the Commissioners, but the Executive's offices avail themselves of training programs through SEMCOG. For an example, there is a Noise Abatement University on May 14th and it is really easy to access. It is right across the street at the Buhl Building on the 3rd floor. If you haven't been there I'd suggest you go there just to look at the literature that they have available. You can register for these web casts online through web casts or pod casts. You don't actually have to go there. Also, we in SEMCOG are co-sponsoring a three part training at MSU regarding economic development. All of these are on the SEMCOG.org website. Finally, I just want to bring it to all of the Commissioners attention that the SEMCOG general assembly will be held right here in the Guardian Building on the 32nd floor with our CEO Bob Ficano as the featured speaker. Any Commissioner is welcome to attend. The general assembly consists of the elected representatives from the six counties in southeast Michigan. The representatives from the commission are Commissioner McNamara, Commissioner Webb and Commissioner Blackwell. I just happen to be the vice-president representing community colleges and also County Commissioner. So please avail yourselves to the services of SEMCOG. Thank you."

COMMISSIONER PARKER: "I just want to comment a little more about Officer Huff. Commissioner Killeen and myself attended an Eastern District Community Relations meeting last night and Judge Noah was there from 36th District Court. I was very surprised again when she explained the cause of budget cuts in the prosecutor's office and in the courts and that it may have been a possibility that the judge that let that individual go did not even have his police record because when the

prosecutor is not represented there, which they had to cut back, they did not know except by asking the defendant what was their previous history. So it could have been a situation where they did not even know that he had priors before they let him go. The other thing is that the Commander was there and the impact that it had on all of the officers. I'm sure throughout the City of Detroit and other places but in that particular precinct that this is the first time that five officers have been shot in one particular area of a district that I have ever seen. It has really done a disservice to not only the City of Detroit but Wayne County and the State of Michigan because it depicted Detroit as a ruined city that is down and out and has no hope of moving forward and I took a particular insult of the little part of the story where they talk about someone hunting coon. We have many more rural areas that hunt all kinds of wildlife and to imply that and include that particular connotation to African Americans, I thought was again an attempt to really misrepresent the City of Detroit, but one good thing about is that it has caused a lot of people to come together and a lot of people are talking about it now. A lot of people want to move forward to try and recreate or give an image of what Detroit really is and myself, Commissioner Bell and Commissioner Williams are part of a coalition, "This is our Detroit". We are going to have an event May 22nd in front of the Spirit of Detroit. We are going to talk about positive actions that we want to take and we're going to take back the image of Detroit that will benefit everybody in the State."

COMMISSIONER GEBHARDT: "I have a date which is Thursday, July 29th.
The lunch is at 12:30 and you have to pre-register online or call SEMCOG.
The meeting starts at 1 o'clock. That's on the 32nd floor here at the Guardian Building."

VICE-CHAIR WILLIAMS: "I want to thank Greg Eno. When the issue with Dateline came out I asked him to write a letter on behalf of the city and county commissioners and he was right on time with it. He sent it to NBC and I don't know if they received it and then I asked him to do something on my behalf and it's been like a month or 3 weeks later, but now Bill Johnson told me it's in the Detroit News. I'm just saying that people need to realize that Detroiters go where everybody else goes and it was a terrible depiction of folks. They were at Mumford High School talking about them stealing computers, but they did not take pictures around the school and there are beautiful homes around there because I am up there every morning running. They pick and choose what they want to highlight for their own news purposes, but at the end of the day you've got some folks that cause problems just like anywhere else. You have some good and hardworking folks that play by the rules where all they want to do is raise their families and go to church. I just think that was terrible.

On a lighter note on May 15th I started a little league baseball team and got ninety kids out. I got them from five middle schools and these young men and women are really great kids. The kids are steadfast and all I ask of them is to coach them, educate them and rough them up when they get out of hand. I will do a press conference but you ought to come and see these little kids that we are raising from babies and I hope they can get into the major leagues."
