REPORT FROM THE CHAIRMAN

CHAIRMAN BOIKE: "Thank you. Good Morning, next week we are looking at Thanksgiving. We must have had a lot of fun because this year went pretty quickly. In all seriousness, it might be a cliché, but next week's holiday is truly a time to take a step back and inventory everything that you have to be thankful for. Certainly, what my family has gone through in the last month, thank God, turned out very positive. We have some Commissioners that we are all praying for that are going through similar situations that I had. They are such good friends and we want that to happen, we have our auditor, one of the finest men I have ever worked with having a situation and reports he will send us a letter every now and again and his spirits are up and high. What I went through, what my family went through, with my wife, Joyce, in October, maybe it is the age thing but all of a sudden you are 67, 68, 70 years old and you have Medicare and that sort of thing, but you know to your family how precious health care is. Health care is so important and so vital, we know how high the numbers are out there and I couldn't afford that even with the high pay I have received all these years as a Commissioner (smile). We are extremely thankful. When you do sit down next Thursday, remember all your friends and all your family, all the loved ones and have a great holiday. Right now I would like to take this opportunity to congratulate our Director of Administration, Bill Johnson, because last week Bill was appointed by Attorney General, Mike Cox, to serve on the new Legacy DMC Board, which will be an oversight group to ensure that the Vanguard Health System remains in compliance with is commitments to the community as it takes over the DMC.
