"The Commission on Reapportionment has completed its work and unanimously approved new Commission districts in a map last week. The process continues, however, I want to make sure that everyone is aware that there are 30 days from the time the maps are filed with the Clerk for people to file for appeals. It has been noted that an appeal is expected, and perhaps more than one. I say that because as I have been talking to individuals throughout the process, that it has been a difficult process. The process isn't over, so I want to advise members to maybe hold off on announcing

that they have new territories or lost certain territories until we are final. I also want to point out that our policies prohibit, as you all well know, any use of County resources to communicate with areas outside of our districts. This is an odd time because we all have a good year and a half remaining to serve the constituents who elected us in our districts as they currently exist, so I just wanted to put that out there and we will make sure that members are kept informed about any appeals as they are filed and as they are moved through the process. It is my understanding that 10 years ago, approximately a month before the filing deadline that maps were actually finalized so keep all of that for your reference and know that the process is not over until it is over.
