C. Report from the <u>COMMITTEE OF THE WHOLE</u> recommending approval of a resolution by Commissioner Parker to place the Public Safety Millage on the November 6, 2012 ballot for the general election authorizing Wayne County to levy an additional millage of 0.970 mills (about 97 cents per \$1000 of taxable valuation) for ten years (2012 through 2021) to fund public safety operations at percentages of 0.485 mills (or 50%) for the Wayne County Sheriff's Office with 20% of the Sheriff's funding for Narcotics Enforcement and Internal Affairs, 0.262 mills (or 27%) for juvenile services (CMO) and 0.223 mills (or 23%) for the Wayne County Prosecutor's Office on the condition that, for any year for which this increased levy would be imposed, Wayne County must budget from general fund an amount equal to its 2012-2013 general fund appropriation for the Wayne County Sheriff's Office, juvenile services (CMO) and the Wayne County Prosecutor's Office? These millage funds shall not be used for acquisition, construction and/or operation of jail, misdemeanant or juvenile incarceration, detention or work/training facilities and adult penalty options.
