Chairman Woronchak advised that there was no Report From the Chairman.

PRESENTATION OF PETITIONS, ORDINANCES AND RESOLUTIONS

At this point in the proceedings, Chairman Woronchak moved to the Resolutions in Memoriam.

Pursuant to the Wayne County Commission Rules of Procedure, a Resolution of Memoriam was read into the record in memory of former Wayne County Commissioner Edward A. Boike, Jr. The resolution is listed below:

EDWARD A. BOIKE JR.

WHEREAS, it is with great sadness that we, the members of the Wayne County Commission, solemnly pause and reflect on the life of a truly celebrated community servant and one of our well-respected former colleagues, EDWARD A. BOIKE JR., who departed this life on November 28, 2017, at the age of 74; and

WHEREAS, EDWARD A. BOIKE JR. was a graduate of Dearborn Fordson High School who went on to further his education at Wayne County Community College District and Wayne State University. He began his long and storied career as an elected official in 1977 when he joined the Taylor City Council, on which he served proudly as chairman for two years. He left the council in 1982 when he was appointed director of the Alfred Sheridan Community Center within the city's recreation department. Under his leadership, the community center flourished with success and became the envy of neighboring communities; and

WHEREAS, EDWARD A. BOIKE JR. married the love of his life, Joyce, in 1964, and the couple settled in Taylor, Michigan, where they raised their two sons, Mark and Todd, and daughter Beth; and

WHEREAS, in 1988, Taylor residents and political leaders alike urged EDWARD A. BOIKE JR. to run for public office again and he promptly won a seat on the Wayne County Commission for District 15, which at the time included nine different Wayne County communities. During his career on the commission, he served in numerous leadership positions, including as chairman from 2009-10, and was passionate about environmental issues and was tapped to chair the Committee on the Environment, Drains and Sewers. He was a member of the Wayne County Drainage Board, Wayne County Solid Waste Planning Committee and the Wetlands Preservation Fund Executive Committee before his fellow Wayne County Commissioners appointed him in 2003 to the new Wayne County Airport Authority, where he was instrumental guiding the transition of Wayne County's two major airports into a new form of governance; and

WHEREAS, EDWARD A. BOIKE JR. will forever serve as an inspiration to those around him, especially his precious grandchildren Alison, Collin, Blake, Carson, Joshua, Samantha and Kole and great-grandchild Wyatt; therefore, be it

RESOLVED, on this 7th day of December 2017, that this resolution endure as a lasting record of acknowledgement and remembrance as the Wayne County Commission - including eight current members who honorably served alongside him - proudly recognizes the dedication and devotion to public service of former Commission Chairman **EDWARD A. BOIKE JR.,** and that a suitably enrolled copy be presented to the beloved Boike family. He will long be remembered as a man who loved his family deeply and cared about the quality of life in his community.
