WHEREAS, it is with heavy hearts that we, the members of the Wayne County Commission, solemnly pause and reflect on the life of a truly celebrated community servant, educator and former member of the Wayne County Board of Commissioners, the HONORABLE DR. CONRAD L. MALLETT SR., who made his untimely departure from this life of September 9, 2017, at age 89; and

WHEREAS, the HONORABLE DR. CONRAD L. MALLETT SR. was born February 2, 1928, in Ames, Texas, to the late LeRoy and Lonnie Thierry Mallett, overcoming poverty and racism and the loss of his father at an early age to graduate with honors from Miller High School in Detroit, Michigan, serve honorably in the U.S. Army and later earn a bachelor's degree in education and a doctorate in education administration from Wayne State University and a master's degree in history from the University of Michigan; and

WHEREAS, elected to the Wayne County Board of Commissioners in 1970, the HONORABLE DR. CONRAD L. MALLETT SR. earned re-election four additional times, serving until 1980. Beginning in 1973, he served as vice president for academic affairs at Wayne County Community College and in 1977 as director for the City of Detroit Department of Streets and Railways; and

MALLETT SR. resumed his educational career in 1983 with his appointment as vice president for student affairs at the Community College of Baltimore, later serving as president of the Capital Region Community College of Hartford, Connecticut, president of the reorganized Greater Hartford Community College and inaugural president of the Capital Community Technical College of Hartford, attaining president emeritus status with his retirement in 1996; and

WHEREAS, the HONORABLE DR. CONRAD L. MALLETT SR. was devotedly married to his beautiful wife, Claudia Gwendolyn Jones Mallett, for 64 wonderful years and the proud father of the Honorable Conrad L.
