REPORT FROM THE CHAIR

"I have a few things today. First, let me remind everyone that's listening that we vet items during our committees. We work in a committee process and during that time, items are thoroughly discussed and vetted, then they come here to Full Board for final disposition. Second, let me thank everyone who participated in last week's Tri-County Summit. The commissions from Wayne, Macomb and Oakland County worked together to put on an awesome event last Friday, at the Edsel Ford House. It was a beautiful location. We had over 100 people in attendance. We discussed the things that we had in common, which are our water, broadband, roads, infrastructure, and it was a dynamic event, especially after having a hiatus for many, many years and we pledged to do this next year again. So, I just want to thank Commissioner Marecki, Commissioner Daub, Commissioner Baker McCormick and Commissioner Anderson for coming out. A special thanks to Tim Johnson, who really worked with the team at Oakland and Macomb County with the details to pull it off. Cynthia, Wayne and Jim, thank you again so much for your assistance in pulling this off, as well. Congressman Andy Levin and Congresswoman Lisa McClain gave opening remarks. We had a video message by the undersecretary of

transportation. We had video remarks from the EPA Region 5 director, and it was just a wonderful event. Our closing remarks were from our very own Senator Gay Peters. It was a treat if you missed it, but we have video if you'd like to watch it in its entirety. And just thank you and we look forward to doing this again. Edsel Ford House is actually in Macomb County. So, next year we'll have it in either Wayne or Oakland County, So, thank you, thank you, thank you for a wonderful Tri-County Summit and we look forward to doing this again, working on how we work together as a region to move our region forward. Also, I would like to at this time have remarks If I could by our CFO, Mr. Hughey Newsome. At the previous meeting, there were some comments concerning the funding for our public health and Mr. Newsome has a very important message about our funding for public health."

Chair Bell yielded the floor to Mr. Newsome.

"I just wanted to kind of clear the air in terms of funding from the state of Michigan. We have not been made aware of any disruption with any funding past, present or future due to the mask mandate. And based on you know we work obviously hand in hand with Treasury and other departments and agencies in the State of Michigan that provide us funding via grant. So, I can assure you that no one in my staff nor myself have been told of any disruptions whatsoever based on this, and so again I will report to the Commission if that were to happen. We do not anticipate that. Corporation Counsel has looked over all the associated documentation laws and they also have not raised any concerns, as well. So, I just wanted to submit that to you, Madam Chair, and to the rest of the Commissioners for the record."

RECONSIDERATIONS

REMARKS BY MEMBERS

Chair Bell yielded her remark to Commission Counsel Felicia Johnson to address the time limit of public comments.

"The Open Meeting Act allows public bodies such as the Wayne County Commission to determine its rules related to public comments. That includes the length of public comments. So, if you look at the Open Meeting Act MCL 15.263 says 'that a person must be permitted to address a meeting of a public body under the rules established and recorded by that body.' The courts have determined that those rules include the time limit for public comments. The statue itself does not specify the length of public comments. So, the statue gives that discretion to the public body. This Commission has established rules. Your Rules of Procedure, Rule 3, does address public comments and does give discretion to the Chairperson to determine the length of time for those public comments, and that is consistent with statue and we are in full compliance."

Chair Bell stated that the State law provides public bodies the option to meet virtually until the end of the year, at which time if the law isn't changed, the Commission will meet in person in January at 500 Griswold, Detroit, which is its regular meeting place. She also stated that more information regarding the Emergency Rental Assistance Program (ERAP) is on the County's website.

Commissioner Haidous asked that Felicia Johnson explain to the public the lack of authority the Commission has over mask mandate or vaccines. Ms. Johnson stated that under the Michigan Health Code, it is the Public Health Officer who issues public health orders, including the current mask mandates for Wayne County. Under the law, the Wayne County Commission has no authority to approve or reject any health order.

Vice-Chair Palamara, supported by Commissioner Baker McCormick, moved to adjourn. The motion prevailed, the time being 11:57 a.m., and Chair Bell declared the Commission adjourned until 10:00 a.m. Thursday, December 2, 2021.
