REPORT FROM THE CHAIR

"Today we have with us a very special guest -- someone who has been a visionary for the Midtown area of Detroit. Ms. Susan Mosey after three decades is retiring from her post as executive director for Midtown. Let me say a few words about Ms. Susan Mosey.

Again, it was a great pleasure that we honor and congratulate one of the finest visionaries for economic development in our region, Susan T. Mosey. Often referred to as the Mayor of Midtown, Susan has been a force serving as executive director for Midtown, which includes the Wayne State area. During that time, she has helped transform the many lives through marketing, real estate and small-business development. Major events emerging from the Cultural Center Association were the creation, such as the Festival of Arts, Noel Night, which many of us enjoy every year, Dlectricity, which is a new exhibit that lights up downtown, the art museum as well as the DIA. In other areas, we are so proud that we could emulate that throughout the city and the County. This is why we recognize her achievements over the hours, the days, the months and the years that she has served to make us all proud of the Midtown area. So, without further ado, I'd like to ask Susan if she would come up, please. We have a proclamation upon her retirement with all 15 Commissioners' signatures, and I would be remiss if I didn't ask the Commissioner who represents Midtown to say a word, Commissioner Jonathan Kinloch.
