"I thought long and hard about whether to respond to the ugly behavior and the lies that have been thrown upon me, specific members of this Commission and this body as a whole. And as Chair, it is my duty to defend this honorable body when untruths and hateful rhetoric are publicly stated on social media and at community meetings. This behavior is unprofessional, unnecessary and quite frankly, hurtful.

The Wayne County Charter states that the role of the Commission is to enact ordinances, approve contracts and deliver a balanced budget. Those are our main responsibilities. The Women's Commission and the Youth Council are programs created by this body, and they can be disbanded by this body if this body sees fit to do so. Just because you don't like an action that was taken by this body does not make it deceitful or unethical.

When 10 Commissioners bring forth a resolution to eliminate a program, the question should be: why? Why did two-thirds of the members agree to end a program? Each member of this Commission is dedicated to the youth in our community and will continue to do so. The Wayne County Youth Council is not the be-all and end-all of the service that we provide to the citizens and to the youth of our community. Each Commissioner here will continue to mentor, support and uplift the youth in this community.

So, despite the ugliness of this past week, I am confident that this Commission will move forward, continuing to do the work of the citizens of Wayne County. I hope we can put this

ugliness behind us. It was unnecessary. It was not reflective of the body of honorable members that are in this room today.

We will revisit the Youth Council, but, as of now, it is disbanded, and we will work to make it better going into the future. Thank you, all Commissioners, for your responses today. I want to make sure that the public is clear, clear on why this happened. We did not take it lightly, and it is really disrespectful to our members and, again, to the young people who so diligently enjoyed working in government and learning."
