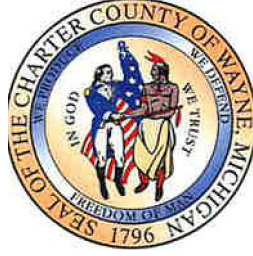

Communication dated September 3, 2024 (received August 5th) requesting Commission approval of Modification No. 2 to a three-year grant agreement between the Charter County of Wayne and the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, extending the agreement by one year, to continue to provide supplemental funding to the Wayne County Sexual Assault Kit Task Force; the amount of the agreement remains \$999,755, with no County match required; Modification No. 2 extends the term of the agreement from October 1, 2020 through September 30, 2025; the revenue from the agreement will continue to be deposited into Account No. 101 22980 529000 (SAKI-2020).
