RESOLVED, by the Wayne County Commission this 15th day of November, 2018 that approval be, and is hereby, granted authorizing Contract Modification No. 24 to a contract with three, one-year options to renew between the Charter County of Wayne and Starr Vista, Inc. (of Detroit) to decrease funding in the amount of \$117,277.14 to account for the third-quarter payment adjustment, as recommended by the Chief Executive Officer; and be it further

RESOLVED, that Contract Modification No. 24 decreases the total contract amount from \$73,338,991.60 to \$73,221,714.46; the term of the contract remains from April 1, 2013 through September 30, 2020 and the cost of Contract Modification No. 24 will be charged to Account No. 292 35612 817000 (Program Development-Juvenile); and be it further

RESOLVED, that the Chief Executive Officer be, and is hereby, duly authorized to execute the aforementioned Contract Modification No. 24 on behalf of the Charter County of Wayne.

1. Appendix C-6, Section XXI, Headed "Maximum Contract Value," is modified by decreasing the contract maximum from **\$73,338,991.60** to **\$73,221,714.46** to account for a quarterly adjustment decrease of **\$117,277.14**.
2. All other terms and conditions of the Contract shall remain in full force and effect.
3. Each party warrants that its agent signing this Modification is authorized to bind its principal.
4. This Modification is subject to the County's policies regarding amendment of contracts.
5. This Modification shall become part of the Contract between the parties and shall become effective upon review and approval by the Wayne County Commission and execution by the Wayne County Executive.
