

MODIFICATION TO ADD FUNDS TO THE LEGAL SERVICES CONTRACT

THIS MODIFICATION TO ADD FUNDS to the Legal Services Contract (**CC # 14-40-012-M2**) is made this **3rd** day of **March, 2015**, by and between the County of Wayne, a body corporate and Charter County, acting by and through the Department of Corporation Counsel ("County"), and **Miller Canfield Paddock & Stone, PLC**, a Michigan Corporation ("Firm").

WHEREAS, on **October 2, 2014**, a Modification to Add Funds to the Legal Services Contract (**CC#: 14-40-012-M1; BO No: 21465405**) in the amount not to exceed **\$100,000.00** was approved by the Wayne County Commission (**Resolution # 2014-568**); and approved by the Wayne County Executive on **October 6, 2014 (PC3#: 37-14-095-M1)**; and

WHEREAS, on **June 9, 2014**, a Legal Services Contract in the amount not to exceed **\$30,000.00** was approved by the Wayne County Executive (**CC #: 14-40-012**) authorized under Section 120-121 (a) of the Procurement Ordinance; for the Firm to provide legal consultation and representation in the matter of **One-Man Grand Jury**; and

WHEREAS, the amount the County agreed to pay the firm has been exhausted, and there remain services to be rendered;


NOW, THEREFORE, it is mutually agreed by and between the parties hereto as follows:

1. Term: **March 4, 2014 to March 3, 2016.**
2. Payment: Exhibit B, Paragraph B, Payment, is amended in the amount not to exceed **\$50,000.00**; and
3. Amount: The modification increases the total compensation that cannot be exceeded under this contract to **\$180,000.00**; and
4. Effect: All remaining terms and conditions of the Contract shall remain in full force and effect.
5. Attorneys: Under this Agreement, the County will pay the following attorney members of the Firm the hourly rate of **\$200.00** per hour;

Thomas W. Cranmer, Esq. Nathan Cortright, Esq.
David O'Brien, Esq.

Paralegal or Law Clerk shall receive a hour rate of \$75.00.


