

**MODIFICATION TO ADD TIME AND FUNDS
TO THE LEGAL SERVICES CONTRACT**

THIS MODIFICATION TO ADD TIME AND FUNDS to the Legal Services Contract (CC#: 12-40-029-M4) (BO #: 21258627) is made this **18th** day of **June, 2014**, by and between the **County of Wayne** ("County"), a body corporate and Charter County, acting by and through the Department of Corporation Counsel ("County"), and **Plunkett Cooney** ("Firm"), a Michigan Corporation.

WHEREAS, on **September 19, 2013**, a Modification to Add Time to the Legal Services Contract was approved by the Wayne County Commission (**Resolution # 2013-630**); and approved by the Wayne County Executive on September 24, 2013 (**PC3#: 37-12-148-M3**); and

WHEREAS, on **December 6, 2012**, a Modification to Add Funds and Time to the Legal Services Contract in the amount not to exceed **\$50,000.00** was approved by the Wayne County Commission (**Resolution # 2012-748**); and approved by the Wayne County Executive on December 10, 2012 (**PC3#: 37-12-148-M2**); and

WHEREAS, on **December 6, 2012**, a Modification to Add Funds to the Legal Services Contract in the amount not to exceed **\$50,000.00** was submitted to Purchasing for PC3 approval and the contract was approved by the Wayne County Commission (**Resolution # 2012-747**); and approved by the Wayne County Executive on December 10, 2012 (**PC3#: 37-12-148**); and

WHEREAS, on **February 14, 2012**, a Legal Services Contract in the amount not to exceed **\$49,500.00** was approved and executed by the Wayne County Executive as authorized under Section 120-121 (a) of the Procurement Ordinance, for the Firm to provide legal consultation and representation in the matter of **Seque v Wayne County and Turkia Mullin**; and

WHEREAS, the term of the contract is **November 21, 2011 to November 20, 2014**, and there remain services to be rendered; and

WHEREAS, the Firm and the County have agreed to execute this Amendment to extend the term of the Agreement and add funds to cover the services to be rendered; and

NOW, THEREFORE, it is mutually agreed by and between the parties hereto as follows:

1. Extended Time: **November 21, 2014 to November 20, 2015**
2. Amount: Exhibit B, Paragraph B, Payment, is amended in the amount not to exceed **\$35,000.00**; and
3. Amount: The modification does the total compensation that cannot be exceeded under this contract to **\$184,500.00**; and
4. Effect: All remaining terms and conditions of the Contract shall remain in full force and effect.
5. Attorneys: Under this Agreement the County will pay the following attorney member a hourly rate of \$200.00.
