Dear Retiree.

We are pleased to provide you with your 2026 Open Enrollment Booklet. This booklet contains important information about your benefits for 2026 which you should read carefully.

This booklet contains information about your benefits, including:

- Highlights of the 2026 Plan Options
- Required Legislative Notices
- Key Contact Information

Open Enrollment begins Friday, October 3 and closes Monday, October 20, 2025. This is your opportunity to:

- Select a health plan from either Blue Cross Blue Shield of Michigan (BCBSM) or Blue Care Network (BCN) for medical and prescription drug coverage
- Change your dependent coverage
- Decline coverage

If you don't want to change your plan, no action is necessary.

All plans being offered are consistent with those offered to active employees and made available pursuant to the Legislative Benefit plan under which you retired. Pre-Medicare Retirees will have the option of three different health plans while Medicare eligible Retirees will have the choice of three Medicare Advantage (MAPD) plans. Medicare-eligible individuals should make sure to enroll in Medicare Parts A & B as it is a requirement to maintain coverage in a Medicare Advantage plan.

Please take time to read this booklet before completing your Wayne County Retiree 2026 Open Enrollment Plan Election Form and keep it for reference throughout the year. It will provide you with information necessary to maintain Wayne County group health insurance for 2026.
