REPORT FROM THE CHAIR

"I was briefed by the Administration regarding the cyber incident that occurred yesterday. They issued a statement to the news and media, which read:

'The County Information Technology Team is aware of a cyber incident targeting some internal systems. We are currently investigating the scope of the incident with our cybersecurity partners, including the Federal Bureau of Investigation (FBI) and the Michigan State Police.'

At this time, no further statement has been provided, as the investigation is ongoing.

I also sent additional correspondence to all Commissioners, which reads:

'We are currently experiencing performance and stability issues affecting access to certain resources on our internal network. Support teams are actively engaged and working to resolve the issue. Affected areas include access to some file shares, remote services, and certain websites.'

To reiterate, the Michigan State Police and the FBI are investigating, which is why we currently do not have access to our files that operate our screens, tablets, and internal systems. As soon as I receive more information, I will share it with you all."
