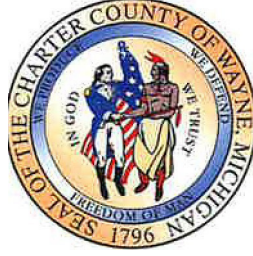

2. Communication dated April 14, 2026 (received May 14th) requesting Commission approval of an addendum to a cooperative agreement between the Charter County of Wayne and WCI Contractors, Inc.
